Pursuant to Article 21, paragraph 1 of the Law on the National Bank of Serbia (»Official Gazette of the Republic of Serbia« No. 72/2003), and with reference to the Rules on the Chart of Accounts and Content of Accounts within the Chart for Banks and Other Financial Organisations (»Official Gazette of the Republic of Serbia« No. 133/2003 and 4/2004) the Governor of the National Bank of Serbia hereby issues the following

G U I D E L I N E S ON DETAILED ACCOUNTS WITHIN THE CHART OF ACCOUNTS FOR BANKS AND OTHER FINANCIAL ORGANISATIONS

- 1. Banks and other financial organisations (hereinafter referred to as the »banks«) shall, within the basic (triple-digit) accounts prescribed by the Rules on the Chart of Accounts and Content of Accounts within the Chart for Banks and Other Financial Organisations, be required to maintain records in detailed accounts as specified in the List of Detailed Accounts within the Chart of Accounts for Banks and Other Financial Organisations, which has been printed with these Guidelines and shall make part thereof.
- 2. Banks shall be required to divide the five-digit accounts of general provisions to six-digit accounts by the method applied in dividing the five-digit accounts of specific provisions.
- 3. The detailed accounts referred to in Section 1 of these Guidelines may further be divided by banks, whereas they shall be required to provide the following information in their books:
 - On liabilities and receivables, by industry;
 - On liabilities and receivables, by maturity;
 - On receivables, by purpose;
 - On liabilities and receivables subject to currency clause, by sector and client;
 - On general indirect write-offs and provisions for losses in off-balance sheet assets, by client;

For the purpose of paragraph one, indent one of this Section, the industry shall mean to include agriculture, hunting and fishing, forestry, mining and power supply, construction industry, processing industry, trade, services, tourist and catering industry, transport and communications, finances, government administration and other public services, etc.

For the purpose of paragraph one, indent two of this Section, the maturity shall mean the following maturities: 1–7 days; 8–30 days; 31–90 days; 91–180 days; 181–365 days; 366–1825 days; and over 1825 days.

For the purpose of paragraph one, indent three of this Section, the purpose of receivables shall mean to include production, trade, export of goods, import of goods, import of equipment, import of consumer goods, privatisation, etc.

4. Banks shall transfer the balances to new accounts after all entries have been posted for the year ended December 31, 2003.

- 5. Banks may use suspense accounts of gyro accounts within the account 139 suspense and temporary accounts of giro accounts, suspense accounts of clearing accounts, and suspense accounts of internal settlement accounts.
- 6. These Guidelines shall become effective as of the date following the day they were published in »Official Gazette of the Republic of Serbia«.
